



Bel Fuse Inc. Announces Regular Quarterly Cash Dividend on its Class A and Class B Shares

JERSEY CITY, NJ--(Marketwired - May 16, 2017) - **Bel Fuse Inc.** (NASDAQ : BELFA) (NASDAQ : BELFB) today announced that its Board of Directors has declared regular quarterly cash dividends of \$0.06 per share on the Company's Class A common shares and \$0.07 per share on the Company's Class B common shares.

Cash dividends for Class A and Class B common shares are payable on August 1, 2017 to shareholders of record on July 14, 2017.

Bel currently has approximately 12,014,000 common shares outstanding, of which 2,175,000 are Class A common shares and 9,839,000 are Class B common shares.
